With the trust and faith of many community leaders and donors, Bonnie did not disappoint them. Her 30th year ushers in \$58 million in assets, over 360 funds, and the new Small Town Dreams Initiative, which provides another spark to area villages, townships, and communities by funding new, innovative, and important dreams.

## NURTURING Entrepreneurs

In 2009, the Barry Community Foundation embarked on a transformative journey with the acquisition of a historic church on Broadway St. in downtown Hastings. With significant support from Larry and Earlene Baum and Doug and Margaret DeCamp, the church was re-purposed into a vibrant community asset: The Barry County Enrichment Center (BCEC). Central to this transformation was the creation of a state-of-the-art commercial kitchen, a cornerstone for local entrepreneurs.

Completed in 2014, the BCEC's commercial kitchen has become more than just a space; it is a catalyst for innovation and a launchpad for small businesses. This facility, which includes a Culinary Arts Teaching Kitchen and Catering Space, was designed to foster entrepreneurship and support startups by providing access to professional-grade equipment and resources.

One such success story is Krug Berry Farm, run by Tina Krug. Established in 2016, Krug Berry Farm has become a local favorite, known for its homemade jams, jellies, pies, breads, and pastries. As her product line expanded to include apple cider vinegar, caramel apples, and hand pies, BCEC's commercial kitchen played a crucial role in this growth, allowing Tina to expand to new product ideas.

"The kitchen is a blessing to us," Tina says. "We are so grateful that we have a commercial-grade kitchen in our county."

# strengthening our Landscape

For over 15 years, the Barry Community Foundation has supported geographic affiliate funds. Thornapple Area Enrichment Foundation (TAEF) joined BCF in 2009 and Delton Kellogg Education Foundation (DKEF) in 2014. The BCF manages the assets and provides a liaison to guide and facilitate, while advisory boards from each respective community determine the direction of its foundation. They create strategies, fundraise, recommend grants for classrooms and community needs, as well as present hundreds of scholarships, many in the loving memories of area students, teachers or community supporters.

As a county-wide philanthropic organization focused on improving lives, one of the most effective services BCF provides is the collaboration and partnership with these two foundations, laser focused on their communities and schools. Established in 1992, TAEF provides community grants for the Middleville area, and scholarships for Thornapple Kellogg High School graduates. With a generous endowment from the George and Doris Leonard Fund, DKEF provides Delton Kellogg Schools with a jump start on grants and scholarships for their students. ## INVESTING IN Main Street

In 2010, community leaders came together to invest in a hotel in Hastings. It was identified as a service gap requiring a considerable capital investment and several investors. A small community was risky for a Holiday Inn, but with the vision and financial support, the Invest Barry fund was born. In partnership with other economic partners and governmental agencies, a construction loan was structured through the fund, which would be paid back with interest over 20 years.

- Five families approached the foundation, requesting our assistance in creating a fund that would support low-interest loans for niche market opportunities.
- 2. Great Lakes Capital Fund, a CDFI (community development financial institution) in Lansing, Michigan, presented recommendations for a loan to build Hastings Holiday Inn Express.
- 3. Partners—The Developer, Hastings City Bank, SBAM small business loan fund, an investor, and BCF - provided loans/capital, and the Economic Development Alliance and the Joint Planning Alliance created a joint services agreement for city water and sewer infrastructure.
- **4.** The 20-year loan was paid back in less than eight years, and the Holiday Inn Express continues to be a successful piece of our community's economy.
- 5. Since then, additional investments have included micro loans during COVID-19, bridge loans for housing-related ventures, and business expansion loans.

## NURTURING TOMORROW Youth in Focus

In 1996, the Youth Advisory Council began with a grant from the W.K. Kellogg Foundation, allowing Middle and High School students to get involved in philanthropy. "We took our responsibility seriously. We were given thousands of dollars each year to invest into programs that benefit kids in our community," says Cloe Oliver, one of the original members of YAC and now one of its advisors. "It gave a group of local teens a chance to be a voice for our peers, and the ability to make a difference."

To date, YAC has granted over \$600,000 to programs designed to benefit youth programs in Barry County and has spent countless hours doing service projects and volunteer work.



In 2015, the KickStart to Career program was launched to benefit every Kindergartner in Barry County. It gives them a chance to think about their future from an early age and provides a savings account seeded with \$50 and an opportunity to earn and save throughout their school years. "Most elementary school students don't think about what they'll be doing five or ten years in the future," says Sam Waller, administrator of the program. "But KickStart gives every child in our county the chance to make that connection, that what they do now can help them in the future."

The Barry Community Foundation remains dedicated to our community's youngest members. The generous support of our donors and supporters allows us the privilege of working with students all over Barry County, and we are so proud to be able to support our youth.

The Shuffle House, Tyden Lofts, and Nashville Flats help meet the goal of providing safe and affordable housing for all in our community just this year. A stable housing inventory is critical to Barry County's economic wellbeing, by ensuring workforce housing. When housing expenses are more than 30% of a family's income, it impacts their ability to afford basic needs.

"It's the domino effect for a healthier community when you create affordable housing," explains Bonnie Gettys, CEO and President of BCF. "The employers love it because it helps their workforce. Schools love it because new teachers can find housing in their district, and even seniors love it because many of these developments are in walkable areas; close to services, restaurants, or even entertainment." When retirees decide to downsize, it opens housing for young families to purchase a new home in our community.

A shining example of the focus on housing is the Village Flats in downtown Nashville. By bridging resources and fostering collaboration, an old, empty school now will provide 20 beautiful, affordable apartments.

### PARTNERSHIPS THAT PROVIDE **Relief**

During the COVID-19 pandemic, BCF partnered with the Barry County United Way and utilized the Extreme Community Needs Fund to help distribute food and personal protection equipment, as well as provide resources for other immediate needs of residents and veterans.

Individual residents weren't the only ones facing challenges, and when outdoor dining became a possible solution to help local restaurants stay open, the Barry County Chamber of Commerce, BCF, and the City of Hastings looked for ways to help these businesses through loans from the Invest Barry Fund. As a result, a grant and gift card program (Feed Barry County) was created to attract customers and combined funding from private donors and the COVID Relief Fund, creating a pool of over \$160,000 to purchase igloo structures and heaters to make outdoor dining a reality!




